Fijian Citizen or Long-Term Resident - International School Nadi School Fees Descriptions

International School Nadi is a non-profit organisation and all funds received are used to cover school operating expenses including:

- IB membership & assessment fees
- Stationary supplies & teaching resources
- Software subscriptions including Managebac, JSTOR, MAP Growth, Turnitin, & anti-virus software
- Electricity, Gas, Water & Rent
- Security services
- IT equipment & WiFi
- Air conditioning, refrigeration maintenance & repair
- Insurance for property & staff
- Training and Professional Development of staff members
- Sanitisation supplies
- Staff salaries & recruitment

All fees are provided in Fijian dollars. Parents and Guardians are encouraged to read through the school fee payment policy if they have not done so already.

Eligibility for school fees for Fijian Citizen or Long-Term Resident

In order to apply for school fees under the category of a Fijian Citizen or Long Term Resident a student must have been living in Fiji for 1825 days (5 years) within the last 10 years. This day count can be confirmed at the Fiji Immigration Department.

ECH Enrolment Fee:

In the event of a student enrolling in ECH the family will be required to pay the enrolment fee of \$500.00. As the student progresses to PYP 1, the family will then pay the remaining \$500.00 towards the enrolment fee of \$1000.00

Re-Enrolment Fee:

This processing fee is to be paid when a student enrolls and then leaves the school only to return again within the next 5 years. The standard enrolment fee will not be charged in this case, but this re-enrolment fee will cover the costs of the additional administration requirements to re-enroll the student. If a student re-enrolls after 5 years, the full enrolment fee will apply.

Development Fee

This non-refundable fee supports the on-going development of the school building and facilities. This annual fee of \$1050.00 per annum is split over each of the 4 terms. The amount of \$262.50 is included in the total for each term.

Resource Levy

This non-refundable fee covers the costs of books, materials, online subscriptions, library resources, Music and Sports Equipment, Art and Science consumables. This annual fee is included in the total for Term 1 or invoiced in the first term of enrollment.

Camps

Non-refundable camp rates apply as below:

PYP 1, PYP 2: \$50.00
PYP 3, PYP 4: \$250.00
PYP 5, PYP 6: \$300.00
MYP 1 - DP 2: : \$400.00

At this stage camps are scheduled to take place during the below terms. This is however subject to change:

Primary Years Programme: Term 3
Middle Years Programme: Term 2
Diploma Years Programme: Term 2

The above fees are included in the respective invoices.

Excursions

Excursions take place over two semesters, at this stage excursions are scheduled to take place in Term 1 and 3. This is however subject to change. The below fees are split over the allocated terms and included in the respective invoices.

Non refundable excursions rates apply as below:

ECH - MYP 5 \$150.00 (\$75.00 Term 1, \$75.00 Term 3)
DP 1, DP 2: \$300.00 (\$150.00 Term 1, \$150.00 Term 3)

Swimming

Students from ECH-MYP5 are required to participate in our annual swimming and water safety programme.

Students from PYP2-MYP5 are currently scheduled to attend swimming lessons in Term 2. Due to pool scheduling ECH is scheduled to attend swimming lessons separately in Term 4. Due to pool scheduling PYP 1 is scheduled to attend swimming lessons separately in Term 1. This is however subject to change.

The swimming rate of \$160.00 per student will be included in the respective term invoice.

External Standardized Testing, Map Growth Testing

Students from PYP3-MYP5 take part in MAP Growth tests twice a year. MAP is an acronym for The Measures of Academic Progress® (MAP®). Map Growth test results provide a summary of academic achievement in Mathematics, Language Usage & Reading.

Online Map Growth tests adapt to your child's responses in real time which means that the tests are tailored to each child's current achievement level.

Map Growth scores help teachers check student performance by measuring achievement and progress over time. Teachers use these results to tailor classroom lessons to students' individual needs and to set goals for students. The results will be shared with parents and guardians.

Map Growth tests take place during Term 1 and Term 3. The MAP Growth tests are charged in the Term 1 Invoice.

PYP 3 - MYP 5: \$80.00

MYP 5 E-Assessment Levy

Students in MYP5 have the option to register for the IB e-assessments. This levy is a one-off payment that is used to cover the cost of the IB candidate registration fees and exam administration fees. The levy of \$1500.00 will be included in the Term 2 invoice for students who opt for e-Assessment.

Diploma Levy

Applicable to Diploma Students only. The Diploma levy of \$936.00 is included in the Term 1 invoice for both DP 1 and DP 2 students.

Security Deposit:

From 2023 onwards a refundable security deposit will come into effect. This will be included in the 2023 Term 1 school fees. This security deposit will be used to cover the costs of unreturned library books, resources as well as outstanding fees. This amount will be refunded to families once the books, resources are returned and once all fees are paid in full. This fee is subject to the refund clause. No credit terms are offered with this fee and a student cannot start tuition until this is fully paid.

English as a Second Language

Students from non-English speaking backgrounds may be required to take a Language Test which costs \$50.00. In the event of Additional Support being required an additional 15% levy will be added to the tuition fee.
